READ THE FOLLOWING CAREFULLY BEFORE SIGNING

If I am elected or appointed to serve as a Volunteer Official on the Board of Directors, or Credit Committee of FEDCom Credit Union, I agree to conform to and abide by the following:

Attend all regular and special meetings when notified unless prevented from attending by circumstances beyond my control.

Seek to learn more about the credit union movement, FEDCom Credit Union and its services and about my individual responsibilities by completing the Core and Required modules of the Volunteer Achievement Program within 12 months of my initial election or appointment as a Volunteer Official.

Attend one credit union education conference/school each year as directed by the chairperson.

Consider the business of the credit union and its members to be confidential in nature and not to discuss such business inappropriately.

Should I ever find myself under obligations to any other group or organization that is in conflict with the credit union, I shall disclose the conflict to the board chairman and refrain from voting or acting on issues related to the conflict.

Participate to the best of my ability in determination of policy and other matters. Give full attention to problems of the credit union, and vote on issues submitted or proposed for action.

Give all assistance possible to my fellow Volunteer Officials and Management of the Credit Union.

Keep personality conflicts to myself and out of credit union business.

Reimburse the credit union for any expenses incurred on my behalf for the attendance of conference, educational seminars, dinners and any other function that I fail to attend without giving sufficient cancellation notice or just cause.

I fully understand that failure to fulfill the duties and responsibilities of the Board of Directors/Credit Committee under the terms of this agreement, the Federal Credit Union Act and the National Credit Union Administration Rules and Regulations may cause my dismissal as a Volunteer Official. I acknowledge that failure to complete the educational requirements, while serving my term, will cause me to be ineligible for nomination as an incumbent for credit union elections.

I certify also that I have a positive net worth and am current on all outstanding obligations. The credit union is hereby authorized to obtain a commercial report on my credit history and seek whatever information is necessary for completing a background check.
